Being an Effective Legislative Liaison – Advocating Locally

Hopefully, each local academic senate has established a legislative liaison: a single faculty member or one serving as a contact representing a group of faculty members. What you can do in February 2022:

- 1. If you are a Legislative Liaison or local Academic Senate President, *share the ASCCC Legislative Reports with your local academic senate*.
