 - The committee members introduced themselves, shared enthusiasm for serving on this committee and the work that is to come.
- 4. Approval of minutes

- 6. Committee Charge *updated April 2021*:
 - The committee reviewed the official charge statement of the LAC committee that was shared on the agenda for this meeting.

7. Announcements

- Ginni May informed the committee that AB 928 did pass appropriations and is currently
 on the CA Senate floor for consideration. There have been amendments, however these
 amendments have made the bill more complicated in regard to unit limits and opens
 additional concerns.
- 8. <u>Committee priorities for 2021-22:</u> Ginni May outlined the process of how the committee sets our priorities (based on assigned resolutions and other assignments as outlined in our charge. These are some of the initial priorities for the committee's consideration).
 - Resolution F20 20.01 The Role of Student Employees in Advancing Faculty Diversification
 - The committee may recommend making this resolution one of our legislative priorities. This is also assigned to the Relations with Local Senates Committee.
 - Budget recommendations and considerations to support this resolution may come from additional partnerships and advocacy.
 - Planning of Legislative and Advocacy Day for spring 2022 see attachments: 2021 Legislative Day visit packet and agenda
 - Visits will happen in the early spring (mid to late February)
 - Documents from the 2021 Advocacy Day were shared with the committee members.
 - Recommendation to ASCCC Executive Committee on Legislative priorities
 - The ASCCC executive committee will consider our recommendations and direct us for our final set of legislative priorities. It is asked that the committee consider additional priorities suggestions for the next meeting.
 - Another emerging consideration is the possibility of a new governor being installed in September and the impact to strategies for promoting our legislative priorities.
- 9. Legislative priorities for consideration and discussion: Find the 2021 Legislative Priorities in the January 2021 Letter to the legislative Liaisons
 - Due to limited time, this agenda item was not fully discussed. The committee will further develop some specific legislative priorities during our next meeting. Initial consideration for possible legislative priorities could be around Transfer Pathways (e.g. simplifying the process, aligning pathways, and overall intersegmental faculty collaboration) and Common Course Numbering initiatives.

 - The committee will jointly draft a Rostrum article connected with Resolution F20 20.01.
 The article may provide background on the topic of what this is and the pros for having this type of program.
