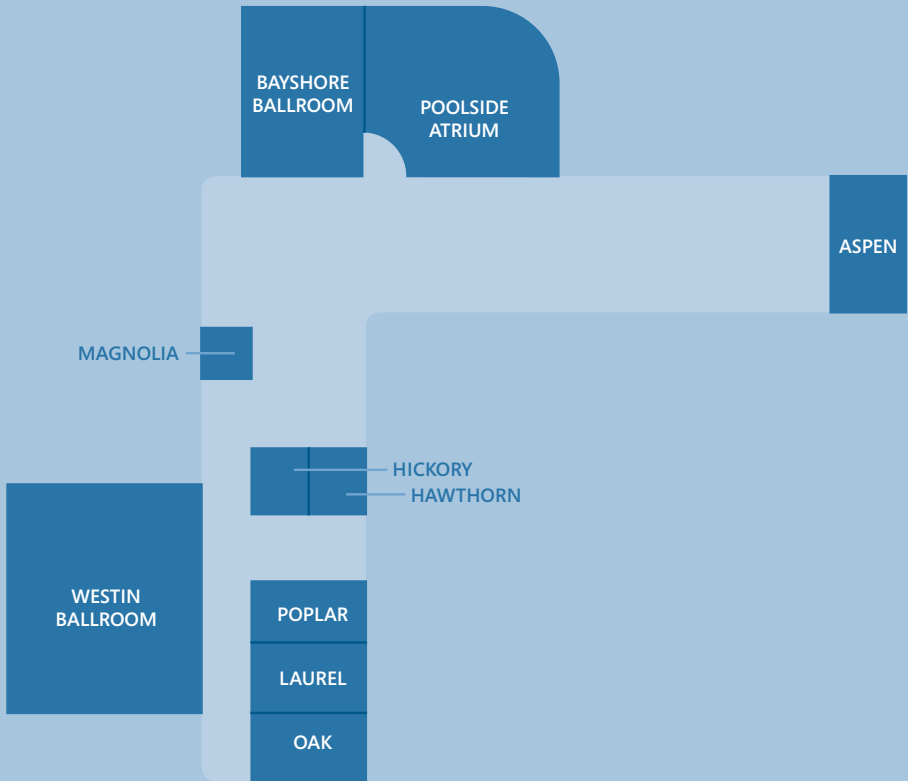

Curriculum is not only the foundation of our educational institutions, it is the first of the “10+1” areas where district governing boards must consult collegially with academic senates regarding policy development and implementation matters. ### **Through The Gate Transfer Study**

With the Chancellor's Office Vision for Success and Guided Pathways efforts aimed at improving college completion and transfer, the RP Group is examining what else we can do to increase transfer for key populations. The Through the Gate transfer study focuses on nearly 300,000 recent students whose course-taking shows them "at" or "near" the transfer gate, but who have not made it through to a university. In this session, we will discuss new quantitative findings that examines the most salient factors predicting whether students transfer to a university or get stuck at or near the gate. We look at student factors such as being first generation college students and participating in special programs, as well as institutional and regional variables like college size and university density. We will conclude by sharing information about Phase 2 of the study, which will explore why these students get stuck near or at the gate.
