Noncredit Instruction in Guided Pathways Efforts

[Resolution S18 17.01 Noncredit Instruction in Guided Pathways Efforts](#) directed the academic senate to:

- recognize the importance of Career Development and College Preparation noncredit instruction as a valuable tool for serving unprepared and underprepared students as part of college guided pathways efforts; and
- provide guidance to local senates on the effective use of Career Development and College Preparation noncredit instruction in guided pathways planning and implementation efforts.

The GPTF is partnering with the Noncredit and Curriculum Committees to address this resolution. The team includes Dana Miho (GPTF), Jan Young (GPTF and Noncredit Committee), Nili Kirschner (Curriculum Committee), Cheryl Aschenbach (Curriculum Committee Chair), and Ginni May (GPTF Chair). LaTonya Parker (Noncredit Committee Chair) is included in correspondence and will participate as needed.

Two breakout proposals have been submitted to the Career and Noncredit Education Institute:

- Using Noncredit Education in English and Mathematics Pathways
- Career Development and College Preparation (CDCP) Noncredit Instruction in Guided Pathways
- *Jan Young is submitting another Guided Pathways/Noncredit/CTE proposal.*

There are also proposals to present some of these breakouts during the GPTF Webinars and Curriculum Institute.

This workgroup is submitting a Rostrum article to help inform the field on this work.

2. Guided Pathways Budget Development

[Resolution S19 5.02 Guided Pathways Budget Development](#) directed the academic senate to:

- urge local academic senates to ensure proper collegial consultation and transparency in developing guided pathways budget processes, including supporting comparability between colleges in multi-college districts;

- work with system partners to ensure collegial consultation and transparency in local guided pathways budget development processes; and
- work with the California Community Colleges Chancellor’s Office and system partners to make available information regarding how statewide resources have been invested in the design and implementation of guided pathways.

Julie Bruno, Jeffrey Hernandez, and Ginni May are putting together a Rostrum article. Nate Donahue, Janet Fulks, and Jeffrey Hernandez are tentatively presenting on this at the spring plenary session in April.

8. [F19 9.09](#) Ensuring Access and Opportunity for Success for all Students Through AB705 (Irwin, 2017) Implementation

Assigned to GPTF, Curriculum Committee, and Noncredit Committee

- Resolved, That the Academic Senate for California Community Colleges remind all stakeholders that the mission of California Community Colleges and the intent of AB 705 is to serve all students, including those who seek a goal other than transfer and those who may benefit from developmental coursework;
- Resolved, That the Academic Senate for California Community Colleges recommend that local senates work with their Chief Instructional Officers to ensure that sufficient developmental, remedial, pretransfer, and/or basic skills courses continue to be offered in order to ensure access and opportunity for success for all students; and
- Resolved, That the Academic Senate for California Community Colleges request that the California Community College Chancellor's Office provide further guidance and clarification to colleges in order to ensure that AB 705 is implemented accurately and in accordance with their mission, so that all students have access to a community college education regardless of their educational goals or level of preparation.

The chairs of the three committees assigned to the resolution can discuss ways to address.

EDAC submitted a proposal for collaboration between the GPTF and EDAC to develop an Equity Assessment tool. This tool would be designed to help colleges evaluate how they are assessing equity implications of AB705 implementation. This tool will not be a “one-size fits all” approach, but rather a repository of questions and recommendations for qualitative and quantitative data collection to assess how colleges are meeting the needs to of their local student populations as they continue to refine their AB705 implementation strategies.
