The Academic Senate conducts a minimum of three award processes each year:

Exemplary Award  
Hayward Award  
Stanback-Stroud Diversity Award

Although many of our campus faculty may be eligible to receive these awards, many colleges do not submit nominations.

# Exemplary Program Award

- Theme – set by the ASCCC Executive Committee
- Board of Governors' Award
- Up to Two Colleges receive
  - with up to four Honorable Mentions
- Cash prize
  - sponsored by the CCC Foundation
- Awardee(s) are recognized by the BOG each January
- Nominations read by:
  - SEAP Committee members
  - at least one representative from CIOs, CSSOs, CEOs, and Student Senate.

- This theme was chosen to highlight the important work that all colleges must do to prepare and promote student performance on assessment for placement exams (e.g., English, reading, mathematics and English as a Second Language) or implement validated alternatives to exams for placement.

# Hayward Award for Academic Excellence

- Four faculty members receive award
  - one from each Area
- Named for former CCC Chancellor Gerald C. Hayward,
- Honors outstanding community college faculty who have a track record of excellence both in teaching and in professional activities and have demonstrated commitment to their students, profession, and college.
- Recipients receive plaque and \$1,250 cash award.
- Call for nominations goes out in November
  - with an announcement letter, application, criteria and scoring rubric.
- Board of Governors award
  - Recipients are recognized by the Board each March
- Sponsored by the CCC Foundation
- SEAP members and Area Representatives will select four additional faculty members from their area to read.
  - Note—no one reads applications for their own area.

# Regina Stanback-Stroud Diversity Award

- Named after former ASCCC Senate President Regina Stanback-Stroud.
- Honors faculty who have made special contributions addressing issues involving diversity.
- Recipient receives cash award of \$5,000 and plaque.
  - presented at each Spring ASCCC Plenary Session.
- Call for nominations goes out in December
  - with an announcement letter, application, criteria, and scoring rubric.
- ASCCC award
  - sponsored by the CCC Foundation.

# Cancellation, Rubrics, Forms, and Rules

- Each award requires at least three nominations
  - does not mean applicants are disqualified, just the process is canceled.
- Each award may have other readers beyond the SEAP committee.
- Each award uses a rubric
  - nomination form follows the rubric.
- Members of SEAP, Executive Committee, or any other readers cannot participate in reading any application where their college is a nominee.
  - This includes receiving a copy of the applications or participating in the discussion about scores or applications.

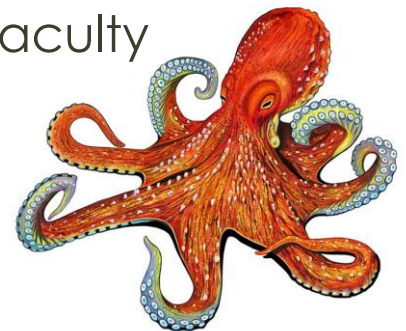






# Periodic Awards

- Norbert Bischof Faculty Freedom Fighter Award
  - Presented to faculty leaders who have exhibited leadership skills by helping to maintain a healthy and functional system of governance or by having demonstrated exceptional courage and effectiveness in support of the adopted principles and positions of the Academic Senate.
  - Named after the Senate's founding father Norbert Bischof.
  - Recipient is selected by the Academic Senate Executive Committee
    - award is granted periodically.
  - Award recipient is recognized during the Faculty Leadership Institute
    - presented with a resolution and plaque.





# Periodic Awards

- CCC Advocate
  - Presented to legislators who have demonstrated commitment to the California Community College System.
  - Award recipient is nominated by Executive Committee members and approved by the Executive Committee.
  - Award recipient is recognized at one of the bi-annual ASCCC Plenary Sessions.
